Election & Bylaws Committee Wednesday, July 24th, 2019, 6:00 PM

Meeting commenced at 6:00 pm

#1 : Introductions – Those present introduced themselves and gave a little bit of backstory about what lead them to be involved in supporting the Mar Vista Community and involvement in the Council.

#2: Minutes – There were no minutes available for approval from the last Election and Bylaws Committee.

#5: New Business

A. Standing Rules:

 The discussion regarding the latest version (4/24/19) of the Standing Rules, resulted in two motions.

The first **MOTION** by Kathryn Wheeler; seconded by Mary Hruska was made to consolidate Articles 1A and 1B of the **FINAL DRAFT MVCC STANDING RULES Apr 24, 2019** resulting in one statement instead of two with the revision reading as follows:

Authority:

These Mar Vista Community Council (MVCC) Standing Rules supersede all prior versions and are subordinate to and must adhere to the MVCC Bylaws, the California Brown Act, the Department of Neighborhood Empowerment (DONE), the Board of Neighborhood Commissioners (BONC) Rules, and all Local, State, and Federal laws that apply...

MOTION PASSED without objection

2. The second **MOTION** by Kathryn Wheeler; seconded by Mary Hruska after amendments were made—Approve the FINAL DRAFT MVCC STANDING RULES Apr 24, 2019 separating the policies from the Standing Rules and send them back to the BOD.

This format would separate the Media Policy, the Tent Policy, and the Code of Conduct Policy as well as possible future policies from the Standing Rules (see attachments). The rationale behind the separation is to simplify updates to any policy as well as to the Standing Rules.

MOTION PASSED as amended without objection

The discussion revolved around why there was no workshop scheduled for the West Los Angeles areas. Mention was made that the increase in voter participation for the area was at its highest this year and wondered why Empower Los Angeles did not schedule a "share-your-thoughts-on-the-2019-nc-elections-in-person" meeting for the West Los Angeles area. **MOTION** by Adriana De La Cruz and seconded by Holly Tilson: To send a letter from the MVCC Board of Directors, requesting that "Empower Los Angeles* schedule a workshop as soon as possible within Council District 11 in order that all the West Area Region neighborhood councils are afforded the same opportunity as the other Los Angeles Neighborhood Councils to provide candidate and stakeholder, in-person election feedback regarding the 2019 Neighborhood Council Elections.
