7.1. Elected Official and City Department Reports – Reports from elected officials, their representatives, or representatives of city departments.

Vishesh Anand- City Council voted unanimously to close the SoCal storage facility in Play Del Rey. Emergency Rental Assistance program is still accepting applications until the end of the month. See hcid.lacity.org. Downtown Mar Vista Beautification Project murals are being installed. CD11 submitted a motion to the City Council to examine funding and feasibility for a range potential sites for homelessness interventions throughout the district, including safe camping, tiny homes and Project Roomkey expansion. Also requesting the City work with Los Angeles World Airport (LAWA) to evaluate that site, and requesting evaluation and funding for a temporary shelter for homeless women at the CD11 West LA offices on Corinth Ave. Additionally are requesting HCID work with CD11 and willing property owners that CD11 has identified to enter into Master Lease agreements for hotel rooms and apartment units. Are confident that this everything approach will help address the homelessness crisis. Safe camping sites will have security and services on site 24/7. Brad Fingard- April 19th the Mayor will be giving the State of the City address. Vaccine update: Johnson & Johnson vaccine administration has been paused affecting a few thousand appointments, which will be honored with either the Pfizer of Moderna vaccines. 936, 000 doses administered so far. Have added a few additional sites including Cal State LA. Starting this week those over 16 can be vaccinated (Pfizer/Moderna). Have launched Homebound Vaccination program. Contact Fingard for appointments.
