"Mar Vista Community Council's Homeless Issues Committee seeks to protect the community from the impacts of homelessness by its commitment to helping homeless individuals who are willing to receive compassionate services, with the objective of (assisting the homeless) obtaining permanent housing and a more hopeful future away from the streets."

#### 7. Committee Discussions:

- a. Updated MVCC "Homeless Resource Guide" and distribution within the community including to LAPD Pacific Division, Mar Vista Library (including The Source program), events where homeless gather such as free meals and special programs, fast food restaurants, etc.) (Funding motion item 7.)
- b. Recruitment of volunteer(s) to compile information and create a "Volunteer Opportunities to Assist the Homeless" pamphlet patterned after Santa Monica City's volunteer opportunities pamphlet with consideration to print. (Funding motion item 7.) *NO VOLUNTEERS TONIGHT*
- c. Consideration to print "Healthy Streets" information sheets (copied from L.A. City handout ) to post at homeless encampment locations to inform homeless individuals and the community of L.A. City rules and restrictions regarding sleeping on public streets. (Funding motion item 7.)
- d. Homeless Rights to sleep on the streets Jones v. City of L.A.

- e. Guidelines for clean-up of homeless encampments. How to request an encampment clean-up 311, MyLA311 mobile app. How can H.I.C. foster better coordination with service providers (LAHSA, etc.) and LAPD and BOS (Bureau of Sanitation) to effect pre-clean up outreach and proper procedures are followed. 0Explanation of and search for potential locations for the Safe Park Park program. Updates on LAMC 85.02 to help reduce the proliferation of vehicle dwelling on Mar Vista Streets.
