We feel that the Community Care Facility Ordinance as drafted is too broad and urge Council President Herb Wesson to hear the entire scope of public sentiment on this ordinance. We urge the Council to work with the community to address this in a way that serves all stakeholders in a manner that addresses concerns of homeowners without painting all group homes as neighborhood nuisances. The MVCC intends to hold a community workshop to explore pros and cons of proposed resolutions and calls for the City Council to authorize, pursuant to section 908 of the charter, neighborhood councils to hold city-wide public hearings.

The Mar Vista Community Council condemns the unfair LA City practice of issuing citations to parked cars at non-functioning parking meters and parking centers. The Mar Vista Community Council further requests that the LA City Council rescind this unfair law and direct LADOT to place new stickers on parking meters advising motorists how to easily notify LADOT of any malfunctioning meter. The Mar Vista Community Council strongly supports inclusion by neighborhood councils as to the planning of any new revenue raising measures by the City of Los Angeles for any construction and/or maintenance of any transportation/infrastructure new and/or existing projects and systems. POLICY MOTION: The MVCC Board urges the City of Los Angeles to fully implement the appeals court ruling in the *Summit Media LLC v. City of Los Angeles* and to remove the 103 illegal digital billboards blanketing our city. We further request that the City refrain from making any changes to the zoning laws relative to digital billboards until the illegal boards are removed and any such proposed change has been subjected to an open and transparent outreach process to community stakeholders.

POLICY MOTION: The MVCC Board strongly supports a Westside City Hall to be established for Planning, Transportation and other related City issues to be held in a location that provides reasonable and appropriate access for Westside residents to have input on issues affecting their region.

POLICY MOTION: The MVCC Board strongly supports a Los Angeles City policy—similar to that in the neighboring cities of Santa Monica and Culver City—for all meetings addressing major issues of Planning, Transportation and other City issues to be held in at an evening time which provides reasonable and appropriate access for City residents to physically attend, and without adversely affecting their daytime employment and family lives.
