POLICY MOTION: The MVCC opposes all illegally-parked RV's and Campers within its geographical borders, and exhorts the LAPD and CD11 office to work with all parties necessary to enforce current laws (such LAMC 85.02), and to prevent proliferation of these vehicles within its borders.

- 8. New Business (with potential motions) (45 min)
- i. POLICY MOTION: Whereas, the LA City Council has recently passed legislation making motorists victims by authorizing LADOT to issue citations to cars parked at malfunctioning parking meters;

Whereas, it is unfair to motorists who have searched for an open, legal parking space, manuvered into that space, gathered their belongings and locked their car, to then find that their coins, or credit cards will not register any time on the meter. It is furthermore unfair to expect that same motorist to return to traffic and drive in search of another space as all the while another unlucky motorist pulls in, to go through the same frustrating ordeal;

Whereas, vandalism of parking meters has reach an all time low, due to the new high tech meters;

Whereas, in an attempt to standardize policies in different jurisdictions state wide, the California State Legislature has unanimously passed SB 1388 to amend section 22508 of the California vehicle code and now allowing a vehicle to park, for up to the posted time limit, in any parking space that is subject to an inoperable parking meter or an inoperable parking payment center.

Whereas, section 22508(b) also provides that local authorities may pass a law to prohibit, or restrict the parking of vehicles at inoperable parking meter, or inoperable parking payment centers, provided they place signs, or markings clearly giving adequate notice of the restriction at, or on the parking location.

Whereas, the extremely small print on the current stickers used by LADOT, do not clearly warn motorists of their intention to issue citations at broken meters.

Whereas, the current Los Angeles law is a disinsentive for City of to quickly repair broken meters, since the ticket revenue is clearly more than the revenue from a properly functioning meter.

Therefore, The Mar Vista Community Council condemns the unfair LA City practice of issuing citations to parked cars at non-functioning parking meters and parking centers. The Mar Vista Community Council further requests that the LA City Council rescind this unfair law and direct LADOT to place new stickers on parking meters advising motorists how to easily notify LADOT of any malfunctioning meter.

Alternative Language: "Until such time as the City of Los Angeles implements a pay-by-phone system that allows motorists to pay for a parking space even if the meter is broken, the Mar Vista Community Council condemns the unfair LA City practice of issuing citations to parked cars at non-functioning parking meters..."
