  - a. POLICY MOTION: Oversized Vehicle Parking Enforcement (passed last T/I Committee meeting 4-0-0, and passed by the BOD in December 2016)
    - Whereas, the Mar Vista Community Council (MVCC) has always sought to be fair and compromising with respect to issues relating to the homeless, oversized parked vehicles, and road/sidewalk access for all 2 residents and stakeholders in our community, and
    - Whereas, the MVCC recognizes that the owners of those vehicles present on our major thoroughfares and streets have both rights and legal obligations as per both court decisions and City laws, and Whereas, the implementation of Preferred Parking Districts is both onerous, expensive, and problematic for both residents and non-residents in the MVCC, and cannot always realistically be pursued or enforced,

The MVCC calls on the City Attorney, the Los Angeles Police Department, the Los Angeles Parking Enforcement Division, and all other City governmental entities, to monitor and enforce a 1000-foot relocation distance for all oversized vehicles, and other vehicles, used for either living or advertising purposes, to be legally required of said vehicles to adhere to this required relocation distance every 72 hours, or face appropriate penalties that include fines and towing.
