- 8. STANDARD ORDER OF BUSINESS
  - DISCUSSION, POTENTIAL ACTION AND PRESENTATION BY PATRICK PANZARELLO FOR 12131 WASHINGTON PLACE (AT THE INTERSECTION OF WASHINGTON PLACE. AND GRANDVIEW BLVD.), CURRENTLY COMMERCIAL BUILDING SPACE. ASKING FOR A CONDITIONAL USE PERMIT FOR THE ON-SITE SALE OF BEER AND WINE FOR OFF-SITE CONSUMPTION IN CONJUNCTION WITH THE OPERATION OF AN EXISTING MARKET / COFFEE SHOP. HOURS OF OPERATION: 7:00 AM – 10:00 PM, DAILY. NO SEATING. FILE NO. ZA-2021-4311-CUB.
  - MOTION was made to postpone voting on the motion until next month by Kathryn Wheeler. Seconded by Mary Hruska. Motion failed with (6) agreeing to vote tonight and (2) voted to table.

- MOTION was made in support of Mr. Panzarello's request by Tyler LaFerriere and seconded by MB Blakely. The motion was approved with (8) approving of the motion and (2) did not approve.
- It was further decided by Chair Andrew Ruesch to hold off on bringing the approved motion to the full board until more time passed to collect further information from stakeholders nearby the project.
- 8.1.[POLICY] [CF 14-1635-S10] DISCUSSION AND POSSIBLE ACTION CONCERNING A COMMUNITY IMPACT STATEMENT (CIS) REGARDING LOS ANGELES CITY COUNCIL FILE 14-1635-S10. THE MOTION SUPPORTS THE CITY'S REQUEST TO ASK THE DEPARTMENT OF CITY PLANNING (DCP) TO COME UP WITH AN ORDINANCE THAT WILL BETTER REGULATE SHORT-TERM RENTALS IN THE CITY OF LOS ANGELES.
  - Motion was moved by Tyler LaFerriere and seconded by MB Blakey. It was approved by unanimous decision and no abstentions.
- 8.2.[POLICY] [CF 15-0129-S1] DISCUSSION AND POSSIBLE ACTION CONCERNING A COMMUNITY IMPACT STATEMENT (CIS) REGARDING LOS ANGELES CITY COUNCIL FILE 15-0129-S1 PROPOSED ORDINANCE THAT WILL ENACT THE PROVISIONS OF THE MELLOW ACT (1982) IN THE CITY OF LOS ANGELES.
  - Motion was moved by Tyler LaFerriere and seconded by Kathryn Wheeler. Fallon and Zeldin moved to amend the motion to include mention of Moderate Income. Tyler LaFerriere and MB Blakey moved to pass the amendment. The motion passed with (1) objection.
