KATHRYN WHEELER SECONDED THE MOTION. THE AMENDMENT PASSED WITH A VOTE OF Y (4), N (2), A (2).

- ANDREW P. MOVED TO AMEND TO READ "THE MAR VISTA COMMUNITY COUNCIL SUPPORTS COUNCIL FILE (CF) 22-0280 IF AMENDED TO INCLUDE SIMILAR PROVISIONS AS THE OAKLAND ORDINANCE. OTHERWISE, IT WOULD UNFAIRLY GIVE LANDLORDS SUBSTANTIALLY LESS INFORMATION TO CONSIDER POTENTIAL TENANTS FOR THEIR PROPERTY. FURTHERMORE, THE MVCC BELIEVES THE ORDINANCE IS TOO BROAD IN ITS PROHIBITION OF A LANDLORD'S ABILITY TO ACCESS AN APPLICANT'S CRIMINAL HISTORY, "AT ANY TIME OR BY ANY MEANS."

SECONDED BY AARON SHUE. THE AMENDMENT DOES NOT PASS WITH A VOTE OF Y (2), N (7) AND A (2).
