- 2. ROLL CALL AND EX-PARTE COMMUNICATIONS/CONFLICTS-OF-INTEREST Roll Call shall include each attending board member declaring any ex parte communications outside of their duties and conflicts of interest pertaining to items on or related to this agenda. - 3. WELCOME AND ANNOUNCEMENTS Jordan Paul announces that there are new water restrictions. Outdoor watering will be restricted to two days a week, sprinklers will be limited to 8 minutes per station, watering using sprinklers with conserving nozzles limited to two 15 minute cycles per day, no watering being allowed outdoors between 9am and 5pm. Recommendations include; using pool covers, washing vehicles at commercial car wash facilities, and no water runoff onto streets.

 - 2nd Vice-Chair Faith Myhra Faith Myhra reports that back in August 2021 a women named Prynsess Brazzle was riding her bicycle and was killed by a hit and run in on Pacific Ave and Rose Ave, in Venice. She was 22 years old. Pyrnsess came to LA to feed people experiencing homelessness and was run down by a hit and run driver. On May 5th a RAINBOWHALO was installed for Prynsess Brazzle 5/5/22 in Venice, CA. LADOT and DCA commissioned the artist John Morse to design a public art piece titled Rainbow Halo. Rainbow Halos will be installed at the location of traffic fatalities to memorialize victims and draw attention to the issue of preventable traffic deaths in Los Angeles.
